#### What is Not Covered?

No benefit will be payable in case of

- Missing or negative COVID-19 Test result
- Claim during the waiting period
- Preexisting case of COVID-19
- Claim for any of the benefits under the plan outside Pakistan

#### What Other Details Should You Know?

- Policy Term: 3 months
- Enrollment Age (Individual): 18 to 60 years
- Enrollment Age (Unmarried Children): Atleast 6 months
- Waiting Period: 14 days
- Death Benefit: Payable only for members aged 18 and above
- Maximum COVID-19 Test Reimbursement Amount (per member) for Family
  Plan: PKR 5,000
- Maximum Hospitalization Days (per member): 30 days
- Maximum Consecutive Hospitalization Days (per member): 15 days
- Gap Between Successive Hospitalization: 30 days
- Geographic Coverage: The product provides coverage in Pakistan only.

- Medical Certificate issued by Registered Medical Practitioner certifying the diagnosis of COVID-19 and a positive COVID-19 lab test carried out at a certified lab
- Claim Form
- Copy of Customer's CNIC
- Any other document deemed necessary for claim assessment and finalization

#### Additional documents for Hospital Cash Benefit:

• Treatment record of hospital which includes dates of admission and discharge, diagnostic report, treatment receipts and prescriptions.

#### Additional documents for **Death Benefit:**

- Hospital Death Certificate & all Medical Records
- NADRA/ Union Council Death Certificate
- Copy of Beneficiary's CNIC

# FAQs about COVID-19 Protect Plan

#### 1. What is COVID-19 Protect Plan?

EFU Life's Buy Now **COVID-19 Protect Plan** is a comprehensive protection plan, which has three benefits bundled into one unique product. In case of positive diagnosis, it reimburses actual cost of COVID-19 test up to a maximum limit. It also provides a daily benefit in case of hospitalization, and lump sum benefit in case of death.

#### 2. What are the product types under COVID-19 Protect Plan?

COVID-19 Protect Plan is designed for individuals and families both. Families include self, spouse and up to 6 children.

#### 3. What is the term of the plan?

COVID-19 Protect Plan provides a coverage for 3 months.

#### 4. What are the benefits offered under COVID-19 Protect Plan?

- COVID-19 Protect Plan reimburses actual cost of COVID-19 test in case of positive diagnosis, up to PKR 5,000 per individual in case of both individual and family plan. For families, the maximum reimbursement amount is PKR 30,000.
- The plan pays daily benefit if any of the covered members is confined to a hospital for at least 24 hours to seek treatment for Coronavirus disease (COVID-19).
- The plan also pays lump sum amount in case of death due to Coronavirus disease (COVID-19) for the covered members over the age of 18 years.
- Coverage amounts according to plan variant are displayed below.

#### 5. How much premium do I have to pay?

Premium is paid once at the time of purchase. Premium amounts according to plan variant are displayed below.

#### 6. What are the eligibility criteria for enrollment?

No medical tests are required for enrollment. Minimum age at enrollment for self and spouse is 18 years, while maximum age is 60. For children, minimum age at enrollment is 6 months.

#### 7. How many family members are covered under COVID-19 Protect Plan Family version?

COVID-19 Protect Plan Family version provides coverage for self, spouse and up to 6 children (unmarried).

# 8. What are the terms and conditions of Hospital Cash Benefit under COVID-19 Protect Plan?

Covered members must be confined to a hospital for at least 24 hours, receiving treatment for Coronavirus disease (COVID-19) in order to become eligible for reimbursement. Maximum number of days for which reimbursement will be payable is 30 days. However, maximum consecutive days of hospitalization for which reimbursement will be payable is 15 days. There must be a gap of 30 days between successive hospitalization.

#### 9. What are the exclusions under COVID-19 Protect Plan?

No benefit will be payable in case of

- Missing or negative COVID-19 Test result
- Claim during the waiting period
- Preexisting case of COVID-19
- Claim for any of the benefits under the plan outside Pakistan

#### 10. When will the policy terminate?

The benefit under this plan shall terminate:

- Upon the Expiry Date of the benefit as stated in the Schedule
- If the Policy is cancelled or terminated in any other manner
- If the Life assured exceeds the age of 61 years
